

Scholarship Season Quickly Approaching!

With scholarship season just around the corner, we offer these important reminders:

- 1) Up to two members from each chapter in good standing may submit a 2023 Mu Alpha Theta scholarship application. Please talk to your sponsor if you're interested.
- 2) Incomplete or late applications will NOT be accepted.
- 3) Only graduating seniors who are registered members with Mu Alpha Theta on December 16, 2022, may apply.
- 4) General academic scholarships are \$4,000, while four special scholarships named for important figures in Mu Alpha Theta are \$5,000.

Get 'em while we have money! — GRANTS

Chapter grants of up to \$1,000 over the lifetime of the chapter are available to help chapters provide interesting mathematical experiences.

Classroom teaching grants will provide up to \$1,500 in funding and are available to a limited number of applicants each year. Any former member who is in their first, second, or third year of teaching mathematics may apply for funds to supply their classroom with mathematics materials or for membership in a professional mathematics organization.




Competition grants of up to \$500 per active chapter are available to help pay entrance fees or expenses associated with a math competition in which the chapter members wish to compete.



Students are not nor can they be sponsors. Students should direct all questions to their sponsors rather than the national office. As a student you should not have access to the sponsor's log in or password.





Results of the Fall 2022 Governing Council Meeting

- It was moved, seconded, and approved that new chapters should have at least 5 members to be approved. Schools can start with a math club and then once approved, they can call themselves a Mu Alpha Theta chapter.
- It was moved by the Finance and Fundraising Committee to support the Mu Alpha Theta Educational Foundation through a donation of \$100,000 from Mu Alpha Theta. Motion approved.
- The new Code of Conduct (on the next page) was reviewed by the Governing Council. It was moved, seconded, and passed to approve the Code of Conduct as corrected and to put it in Sponsor's Packet.
- The 2021 Federal Tax forms for both Mu Alpha Theta and the Educational Foundation were reviewed and approved by the Governing Council.

MAΘ Code of Conduct



Mu Alpha Theta National Mathematics Honor Society strives to integrate community, inclusivity, communication, and teaching & learning across all its work. MAΘ is advancing the understanding and enjoyment of mathematics, and strives to facilitate and support environments that foster this goal. As an honor society, MAΘ is committed to providing an inclusive climate that encourages the open expression and exchange of ideas, that is free from all forms of discrimination, harassment, and retaliation, and that is welcoming and comfortable to all members and to those who participate in its activities. In pursuit of that commitment, MAΘ is dedicated to the practice of equal opportunity, respect, treatment, participation, and outcomes for all regardless of gender, gender identity or expression, sexual orientation, race, color, national or ethnic origin, religion or religious belief, age, marital status, disabilities, veteran status, political affiliation or belief, field of expertise in all interactions and activities. This philosophy applies to all MAΘ activities including conventions, publications, programs, and governing structures and bodies.

MAΘ expects the standards set in this Code, as articulated below, to be upheld by its members; leaders; staff; awardees; and participants in meetings, conventions, events, or social media exchanges regardless of the capacity in which they are performing (be it as an individual, organizer, delegate, speaker, sponsor, exhibitor, or in any other capacity). The professional behavior and communications of MAΘ members, sponsors, and staff must reflect an environment that is safe, respectful, and supportive of others.

The code applies to the behavior of members of MAΘ and individuals who interact with MAΘ in their professional lives. These expectations apply to the teaching, research, service and other duties carried out by MAΘ members in their workplace and their behavior in the mathematical community. Violations of any part of this Code can be reported to the MAΘ Governing Board and may result in consequences described herein.

We expect that the MAΘ staff, MAΘsponsors, MAΘ members, and affiliated parties (non-members attending or supporting MAΘ events) will:

- ◆ promote the enjoyment, study, application, teaching and understanding of mathematics;
- ◆ act with integrity, and strive to be objective, unbiased, and truthful in all aspects of our work;
- ◆ act to support MAΘ's commitment to promoting diversity, equity and inclusion;
- ◆ never intentionally discriminate against another person on the basis of gender, gender identity or expression, sexual orientation, race, color, national or ethnic origin, religion or religious belief, age, marital status, disabilities, veteran status, or field of expertise
- ◆ avoid biased, demeaning, intimidating, coercive, or harassing/hostile conduct or commentary, whether seriously or in jest (e.g., based on power differential, gender [sex, identity, expression], sexual orientation, race, ethnicity or national origin, religion, marital status, veteran status, age, body size or other physical appearance, disability, or other identities);
- ◆ never bully, abuse, victimize, or engage in harassment of any kind, including sexual harassment, whether via spoken or written words, emails, offensive images or graffiti, social media posts, or any other means;
- ◆ avoid injuring others, their property, reputation, or employment by false or malicious action;
- ◆ be respectful of the privacy of others and the protection of their personal information and data;
- ◆ accept and offer honest criticism of technical work, acknowledge and correct errors, and credit properly the contributions of others;
- ◆ do not claim authorship of something that is not yours and do not claim sole authorship of something created with another person or in a group setting;
- ◆ demonstrate that differing perspectives are valued by critiquing only ideas (not people);
- ◆ answer questions about conduct concerns in a forthright and complete manner;
- ◆ assist colleagues and co-workers in their professional development and support them in following this code of conduct;
- ◆ avoid real or perceived conflicts of interest whenever possible, and disclose them to affected parties when they do exist.

Violations of this MAΘ Code of Conduct by any member, sponsor, or affiliated parties may result in:

- Written reprimand from the MAΘ Governing Board
- Removal from the MAΘ event or convention
- Banning of individual or group from future MAΘ conventions

These consequences would be regardless of status, role, or title.



Why My Chapter has a Code of Conduct!

To existing and new chapters:

In the time and day that we live in, we as a National Honor Society need to adhere to what an honor society is about. Normally, it is known that we need to be respectful and honorable and be a reflection of what an honors society

adheres to. A couple of years ago, I had a situation of some negativity geared towards a teacher of our school. Even though names weren't mentioned, the entire community knew who it was geared towards and it created a little bit of turmoil. Because that member was in the chapter of Mu Alpha Theta, folks wanted reprimand for that student's actions. Since we did not have a Code of Conduct in writing, according to the legal officials of our county school board, nothing could be done towards that student. We are known as an

honor society and we are to act accordingly, but if the chapter doesn't have anything in writing that shows what consequences could be given, members/sponsors cannot legally be reprimanded. So my council developed a code of conduct and made sure that it addressed the social media aspect of what is proper and not. The following year, a student was caught cheating in a class, and because we did not have that in the written code of conduct, verbatim, that student could not be reprimanded either. Yes, it is a touchy subject, but legally if you do not have anything in writing, you cannot legally reprimand an individual even though its known that it is wrong. I hold my council to a higher esteem than the county board of education codes, so possible scenario that we could think of is addressed in my chapter's code of conduct. Florida Student Delegates Invitational

The 3rd Annual Student Delegates Invitational will be held November 19th, 2022! The event will be completely online. Students must register by the November 15th deadline <https://forms.gle/DoF7pPATMsP2kSGw5>. Below is the competition schedule.

1:00 P.M. - 2:15 P.M ET: Individual exams will be proctored via Zoom (two-device profile required). The individuals offered are Theta, Alpha, Mu, and Statistics. Upon joining the Zoom call and instructions being read, a PDF test will be emailed to all registrants. After the test ends, there will be a ~2 minute period to upload your answers via a google form also available in the announcements.

2:15 P.M. - 2:40 P.M ET: Answers and solutions will be released. You will have 35 minutes to submit disputes via Google Forms.

2:30 P.M. - 3:30 P.M ET: We will host a Student Delegates information session and introductory meeting. There is no cap on the number of attendees per school.


By 11:00 P.M ET: Awards ceremony with top 20 individuals per division will be recognized on the Student Delegates Youtube Channel.

made with over 350+ youngsters in attendance.




Monies were raised for a scholarship fund for a neighboring high school who lost a star freshman soccer player in a car wreck a couple of months before.

- 2. Log1 Host Needed for 2023-2024!**
 - a. The Log1 Contest provides an excellent opportunity for a school to participate in a competition similar to our National Convention contests and compete against schools from across the country and the world, while staying right at their home school.
 - b. Students compete only against other students with similar mathematics course background.
 - c. Regrettably as of today, we do not have a host school for 2022-2023.
 - d. Mu Alpha Theta pays for award expenses, and the chapter is paid a stipend. Past Log1 tests are posted on the website.



Sponsor's Page



1. Once a student is a member of Mu Alpha Theta, they are always a member of the national organization. Your rules may remove them from your chapter, but they remain a Mu Alpha Theta member. They would not qualify for a scholarship since you would be the one to submit the recommendation.
2. Names are printed exactly as you submit them. Please be sure to edit your file.
3. When ten or fewer certificates are ordered, they are sent by snail mail (USPS).
4. The National office will be closed **Wednesday – Friday, November 23-25** for the Thanksgiving holiday.
5. **Our store will close again at 5 pm CT on Friday, December 16.** Your members must be registered and paid for by this time if they want to be eligible to apply for a 2023 scholarship or summer grant!
6. When placing orders, please be mindful of your school's holiday closing schedule. You are responsible for extra shipping charges if your package gets returned to us due to school closure or incorrect address.
7. We'll email you in early December if you have a shopping cart. Names in your shopping cart are not actually members until the shopping cart has been fully submitted and paid. The shopping carts will be deleted over Christmas break so you would need to start all over in January.
8. The National Office will be closed starting at 5:00 pm CT on Friday, December 16, and will reopen at 8:30 am CT on January 3, 2022.
9. Our scholarship application submission deadline is February 1. Only two graduating members from your chapter may apply. Please encourage your members to consider applying! Online applications are available now. We do not accept paper scholarship applications.
10. We'll email you soon if you have an unpaid invoice. Our fiscal year ends in December, and it helps us immensely when all unpaid invoices are paid.
